



### **MESSAGE FROM OUR MENTOR & GURU**

As Mentor to Sarthak, it is my duty and pleasure, every year, to write the Foreword to the Annual Report. I am delighted to do so for this Report for the year 2020-21.

As readers will recall, India was hit hard by Covid-19 in early 2020. The Gol declared a National Lockdown in March 2020. Since then, there have been state, city and local level lockdowns. Even organized big business was initially perplexed on how to cope with it. Innovations came in the form of Work from Home (WfH); Work from Anywhere (WfA) etc. Sarthak was among the early NGOs to quickly adapt to these new trends. It switched from "physical" training in our 24 Centres around the country, to "virtual" training. Our trainers did WfH. Our PwD trainees did LfH, Learn from Home! The transition, naturally, was not easy. Team Sarthak solved all the small and big problems en route.

Covid did not stop or slow down Sarthak. On the contrary, the team did many new things. It differentiated different types of programs. The core program is JEET, for the Employment and Empowerment of Divyangs. In the 12 months, from November 2020 to October 2021, more than 3500 were trained. At the request of many of our Job Partners, Sarthak organized Sensitisation Workshops for their employees. These included some Tata Group companies, Reliance, Infosys, Mondelez, Puma etc.

The second category is the Digital Literacy Program. Some of the trainees were given assistance for Self-Employment and Entrepreneurship. The third type, the Campus Connect Program has been successful beyond our initial hopes. Sarthak reached out to 93 Engineering institutes, all over India. Training is ongoing. Naturally, they are getting better jobs, with more attractive compensations.

The pandemic has not stopped Sarthak's expansion. On the contrary. Sarthak, with the help of generous donors, has been able to open new centres in different parts of the country --- Thiruvananthapuram, in the south; Ahmedabad, in the west; and Varanasi in the north.

Another worthy initiative is the start of Consultancy Services, for companies, under Sarthak Divyangjan Foundation. The areas of consultancy are --- Accessibility; Recruitment of PwD; Job Mapping; Sign Language etc.

Last, but, of course, not the least, is the growing seva of Sarthak to children from birth to the age of 5, to minimize any congenital or later disability; mitigating it; developing motor, speaking, drawing etc. skills. Our Early Intervention Centres are like Sun's rays into the initially dark world of those children, parents, and other caregivers.

On behalf of Sarthak, my deep thanks to all our partners, especially the Donors and Employers. My continuing ashirvads and praarthanas for the vijayam of our trainees; alumni; and Team Sarthak.

It's my pleasure and privilege to connect with you all through our Annual Progress Report. When distance is the norm in the current day and time, getting digital help to stay connected. And, here we are with our digital version of Annual Report themed as: Digital Divyang – Enabled & Empowered.

Digital Divyang is not just a metaphor, it's a hope for the future. Getting Digital promises an Enabled and Empowered Divyang. A divyang who can act independently, dream for his future and make that dream come true.

This hope of ours took shape this year. When the virtual world came up as an alternative due to COVID, we witnessed readiness and enthusiasm within our beneficiaries towards digital mediums. And, thus with the aim to touch more lives and catalyze their empowerment we came up with digital solutions like CapSarathi 2.0 – Web Version/Mobile App for PwDs & Rozgar Sarathi – Job Portal for PwDs. To further strengthen this we have started a digital literacy program & trained 4500 PwDs.

We completed 13 years of our service to PwDs this year. And, in all these years we have outreached 0.8 million PwDs, rehabilitated 2670 children with disability and trained and placed 34300 and 23450 respectively. We have also been able to open three new skill building centers this year in Kerala, Gujarat and Uttar-Pradesh. We have also created ripples of our movement in university campuses through our campus connect program and provided placement support. Online Training and assessments of national winners of


Abilympics are also going on and we are all set to represent India in International Abilympics in Moscow in 2022.

This year has also been full of wonderful advancements and newer innovations as we have moved all of our programs to an online mode of functioning. This has also acted as a boon as physical distance or lack of mobility is no longer a challenge when trying to impact the lives of our beneficiaries.

In a world that is more connected now than ever, it is extremely important to forge alliances and create systems to share resources. We opened up a UK chapter this year as an effort to create a global outreach for our cause. Furthermore, for rural outreach & creating more grassroots level networks we are actively working for our initiative IDEA - India Disability Empowerment Alliance. We have been also working for a Global Resource Center for PwDs to come up with a State of the Art model and facilities for PwDs under a single roof.

Sarthak, ever since its inception, has been dedicated towards its cause in empowering persons with disability to lead a life of respect and dignity. And thank all our supporters and well-wishers for their continuous support and blessing to lead us to this level. Keep on motivating and guiding us and being the part of this movement towards Enabled & Empowered Divyangjan.

## Bouncing Back \*Moving Forward

...and a desire to touch the life of every PwD in the country

As you are aware, we have all been through an unprecedented time for nearly 21 months. Ever since the deadly pandemic struck around mid-February / early March 2020, the next 1-1/2 year was an unmitigated disaster. Tens of thousands saw family members and friends suffering and dying, many lost their jobs & businesses, industrial units were shut and so were schools & colleges; millions engaged in services and on shops in big cities went back to their villages; there were many lockdowns and everyone's life was disrupted. Panic was not confined to India; the whole world was engulfed in misery. For our PwDs, the suffering was infinitely worse due to limited mobility and lack of access to medical care and hospitalisation. I am glad to share that despite all odds, Sarthak admirably managed to continue its work. Team Sarthak - with its highly committed and dedicated officers in all verticals and guided by the indefatigable CEO Dr Jitender Aggarwal - rose to the occasion and successfully adapted 'work from home' culture for almost all its activities including imparting skills, job fairs & placements, helping those in distress, early intervention, advocacy & fund raising.

I am happy to share that in the year 2021, one of our flagship initiatives 'Jobs, Entrepreneurship & Employment Programme' (JEET) has (a) completed training of nearly 3,500 persons and another 1,500 are undergoing the same (b) 1,300+ have been placed (c) 11 Sensitisation workshops were organised with leading companies like Mondelez, Tata Communications, Infosys, Reliance and others. Another initiative 'Digital Literacy' managed to empower 4500

persons and provided self-employment / entrepreneurship assistance to 1150 in the same period. Yet another programme 'Campus Connect' reached out to nearly 100 engineering institutes across India and new Skill Building Centres were set up in Kerala, UP and Gujarat.

Going further, Digital Solutions like the app CapSarathi is helping PwDs all over the country to connect with us and find out all information about government and private assistance programmes and employment. A dedicated job portal RozgarSarathi and E-learning app GyanSarathi are under development. Lot of work is going on for facilitating sale of products made by PwDs on the government e-commerce site GeM. Even Therapy Sessions for Early Intervention Beneficiaries are being delivered on-line using audio-visual home based activity guidance material.

Overall, the brave and innovative approach by Sarthak has ensured that misery of the PwDs is mitigated and they continue to find jobs with dignity as indeed they could before the pandemic.

My greeting for the festive season and best wishes to all Divyangjan, our generous sponsors and other benefactors and our pride 'The Team Sarthak' for good health, happiness and God Speed towards our Founder's goal of touching the lives of all PwDs in India..

# The year that was and the years to come - Message from our Trustees



Team Sarthak has been able to achieve a number of milestones this past year and has taken great leaps forward in our mission to empower persons with disability through skill building and sustainable employment. We have been able to open three new skill building centres in UP, Gujarat and Kerala.

Digitalization has been the flavor of the year keeping in mind the adoption of work from home as the norm. We pursued our Digital literacy vertical with great enthusiasm and velocity as we realized that the virtual or online space is the key mode of empowerment. We were able to successfully train 4500 PwD candidates in digital literacy and provided 1150 with the appropriate modes to empower themselves.


Our Early Intervention Vertical has also moved online. The team has also been able to begin Online Training Sessions for the parents of children with special needs. This has helped us create a better environment for the children and also take the parents into confidence.

Our skill building vertical continued to grow online. The trainers' team has also been diligently working on providing an enriching and interesting learning experience.

This year, in a bid to increase outreach activities, Team Sarthak has also conducted sensitization workshops and offered consultancy services to corporates under Sarthak Divyangjan Foundation. Working with corporate stakeholders is a key component to ensuring that Persons with Disability have access to sustainable employment at equal opportunity workplaces. So far, we have conducted 11 Sensitization workshops with corporate companies like Puma, Tata Communications, Schindler, and Urban Company among others. Other corporate consultancy services that we offer are Job Mapping, Sign Language Support, Recruitment Support, and Accessibility Consultancy.

CapSarathi, our mobile application providing information services to Divyangjan was released in 2020. This provided the team incentive to work on creating more tools of digital empowerment. This resulted in the creation of RozgarSarathi- the job portal for PwDs and GyanSarathi- the knowledge and education portal for PwDs & changemakers.

We wish to keep up with this momentum of change with newer innovations and sustained efforts in our current projects as well as stay open to newer beginnings.



As per the 2011 census, over 2 crores of the Indian population lives with a disability. This section of population has also been noticed to have lower labour force participation and education levels. There continue to remain a number of gaps in the provision of basic needs and rights to persons with disability. The inclusion of persons with disability and making sure they lead a life of dignity is a developmental goal that requires cross cutting action across various sectors. True development concentrates on equity and inclusion and this can only happen when nobody is left behind. It is only through inclusive and sustainable development that we can create real positive change.

As an organization, one of our motivations is to help empower persons with disability at every step of their life. It is with this as a guiding principle that we have tried to work on disability at a number of different levels. This journey began with eight visually impaired students in Delhi and through persistent efforts by Dr Aggarwal and team Sarthak, we now have 24 centres across the country. Through these centres, we have managed to train and place over 34,300 and 23,450 persons with disability respectively. In addition to this, we have been able to provide over 2670 young children with rehabilitation through our Early Intervention Services.

As an organization, we strongly believe that inclusive model education right from the foundational level is the first stepping stone in creating a disability inclusive society. In order to make this a reality, we have been able to successfully rehabilitate over 500 school going children with disability into mainstream schools through sensitizing the various stakeholders and providing the students with remedial classes.

The efforts made by our team have brought great joy to a number of beneficiaries. This includes candidates from our skill building sessions, children with special needs as well as their friends and family. For instance, parents of early intervention beneficiaries have noted considerable improvements in their children. Deepak has been receiving therapies for Attention Deficit Hyperactivity Disorder at the Ghaziabad Early Intervention Centre. His mother notes that there has been considerable improvement in his symptoms. He has learnt to follow commands better, is able to sit still, and pay attention. His mother is very happy with these developments and appreciates the efforts of the early intervention staff. It is through similar sustained efforts in our various programmes that we wish to move towards achieving our goal of an inclusive and disability friendly society.

# Early Intervention - Therapy Services for Children with Special Needs



Sarthak's Early Intervention Programme was begun with the intent of strengthening therapy systems in order to ensure that children with disabilities and their families have access to high quality and culturally appropriate rehabilitation. Sarthak's Early Intervention Services are targeted towards providing a child with special needs with appropriate therapies as per their assessment while also engaging parents into the process.

As of now, Sarthak's Early Intervention Centres offers therapies to children diagnosed with Autism Spectrum Disorder, Mental Retardation, Down Syndrome, ADHD (Attention Deficit Hyperactivity Disorder), Cerebral Palsy, Learning Disability, Speech and Language Disability as well as sensory disabilities. So far, Sarthak has successfully rehabilitated over 2670 children with Special Needs.

#### Why Intervene Early?

- 1. Enhance Child's normal development

#### Highlights of 2021

The Early Intervention Programme has been seeing wonderful results through the course of 2021. Some highlights of the year are as follows -

#### Stories of hope - Aafiya

As parents, one gets great joy from seeing their child grow up and do things on their own. In the case of a child with cerebral palsy, many of these simple joys are missed by the parents. Aafiya's parents noticed that their child was not able to sit and stand. Feeding her was another challenge as she was not able to chew food. They brought her to Sarthak's Ghaziabad Centre & once she began attending sessions regularly, one could notice considerable improvements in her. She can now sit without support and walk with a little support. Her drooling has reduced and is able to chew properly. She is also able to understand and follow commands and even reply in small phrases.

#### **Stories of Hope - Arnav**

Arnav's parents realized that their son's speech was delayed, he wasn't responsive to sounds, and remained lost in his thoughts most of the time. This lack of communication with their son caused the parents a great amount of distress. At first the parents took him to an audiologist as they suspected hearing impairment. However, his auditory assessment revealed that his hearing was well within the normal range. The pediatrician then recommended psychological assessment of the child and he was diagnosed with mild Autism. Therapies were started at Sarthak and in 6 months he started showing improvement. Now, if one meets Arnav at the Ghaziabad Early Intervention Centre, they come across a responsive four-year-old who wishes to engage with his surroundings and indulge in play.



#### Stories of Hope - Vimal

Assistive Devices are extremely important when making sure children with disabilities can make progress. However, this needs to be coupled with appropriate rehabilitative therapies. Both need to go hand in hand. Vimal's case is very telling of the same. He was recommended a hearing aid but even after getting one he couldn't make a lot of progress.

His parents brought him to Sarthak wherein, he was exposed to various sounds and was taught identification, discrimination and vocalization of sound. Our therapists then worked on building his vocabulary and taught him how to frame phrases and sentences. At present he can speak in small phrases, has improved and increased vocabulary and is thorough with concepts like alphabets, numbers, matching, counting and writing, fruits, animals, colors, transports etc. His family is extremely happy with the level of progress they can see in Vimal.

# Inclusive Education - Dreaming of Equal and Inclusive Learning Opportunity



The national average of enrolment in school is over 90% but less than 5% of children with disability are enrolled in schools. About 40% of the enrolled students with disability are not able to complete the first 5 years of their basic education, while another 20% leave school prior to the completion of three years of free and compulsory education mandated by our Constitution.

As of now, the central government's Sarva Shiksha Abhiyan (SSA) is the main programme for the universalization of elementary education. SSA lays emphasis on an inclusive mode of education where students with special needs study along with able bodied students.

Under the New Education Policy (NEP), 2020, one of the provisions is that of "Barrier Free Access to Education for all children with disability". The modifications are made keeping in mind that a number of students with special needs may come from socio-economically disadvantaged backgrounds and may require extra support from the school system. The implementation of this provision of the NEP will put to action the promises of access to education as made under the Rights of Persons with Disability Act of 2016. However, as per the RPWD Act of 2016, children with special needs still have the option of regular or special schooling.

In light of all these policies, a number of reasonable accommodations are to be put in place for children with special needs. Every school is expected to have a special educator and child counsellor on campus. Other than this, there have also been promises of a sign language module that will be introduced in schools.

#### **Our Efforts for Inclusive Education -**

We at Team Sarthak have been working in the field of Special Education for a while now and welcome these policies. With the intent to create a positive shift in the direction of education of CwSN in inclusive settings, Sarthak started its Inclusive Education endeavour by conducting primary screening and identification study in 10 Government Schools. Herein, the students were assessed on various parameters such as Health Status, Intelligence Quotient, Education level, with respect to their ages and 425 children with special needs were provided required remedial classes, medical and psycho-social rehabilitation.

Our Inclusive Education vertical also ties up with our Early Intervention modules. A number of children who have received early intervention rehabilitative therapies have been able to go on to join mainstream schools.



#### Stories of Hope - Hardik

By the time that students become old enough to join school, they are willing to socialize with others, play with other children and show more advanced social skills. This is often not the case with children on the autism spectrum. Hardik's parents had a similar experience with their son. When his parents first brought him to Sarthak, his mother was worried about how he wouldn't make eye contact, wouldn't respond to people, and preferred to play alone. She also tells us that his speech wasn't clear and they were really worried.

His mother also took a great amount of interest and underwent training to provide home based therapies. Over time, it was noted that he was making slow but sure progress. This motivated the parents even more. He is currently enrolled in class two at a regular school. He is able to carry out his daily academic activities at the school's pace.

Hardik is one of our success stories from early intervention to inclusive education. The positive impact of rehabilitative therapies in his case stands testimony to the importance of intervening early.

#### Stories of Hope - Deepak

Ten-year-old Deepak's teachers had a number of complaints about him. He was not performing well at school, he was bumping into people and things, disrupting the classroom environment, and would never complete his assignments. Oftentimes, his teachers would send him home for being disruptive and not listening to instructions.

Worried, his parents brought him to Sarthak Educational Trust. Here he was diagnosed with Attention Deficit Hyperactivity Disorder. His parents were counselled on the condition and rehabilitative therapies were recommended. Over the past year of receiving therapies from us, Deepak has shown considerable progress.

He is currently enrolled at a regular school and is keeping up with the regular coursework. Deepak's story is an example of how children with disabilities can in fact study and follow a regular curriculum in an inclusive mode of education. What is required is proper knowledge and understanding of childhood disabilities coupled with rehabilitative therapy.



Skill Building
- Employability Enhancement Programme






In order to be successful in finding employment and performing well at one's job, one needs to acquire certain skills that make them job ready. These include basic skills like English speaking, Professional code of conduct as well as job role specific skills. Often times, Persons with Disability need an extra push in getting jobs due to lack of appropriate skills as a result of inaccessible education systems. Sarthak attempts to fill these gaps through our Skill Building vertical. We provide free of cost training courses to Persons with Disability so they can get employed and gain financial independence.

## Sarthak JEET (Job Entrepreneurship and Empowerment Training)

Sarthak JEET is a three-month long training programme for Persons with Disability between the ages of 18 and 35. This programme is focused towards providing youth with disability with the appropriate skills and training to make them job ready and be financially independent. Over the years 2020 and 2021, Sarthak has been able to successfully carry out online training for PwD candidates.

The project focuses on aspects like - Employability Enhancement (Skill Development) and Sustainable Employment of persons with disabilities. Sarthak currently has a total of 24 skill building centres across the country. Of these, three centres - Ahmedabad, Thiruvananthapuram, and Varanasi, have been opened in 2021. The past year, we have initiated completely online based training for a number of cohorts. In the year 2021, we have trained 3500 Divyangjan candidates and 1500 candidates are currently under training.



#### Sarthak Digital Literacy Programme

Our Digital Literacy programme was launched with the intent of bridging the technological gap and providing persons with disability with appropriate training through a 15 day intensive programme. Ever since its launch, the digital literacy programme has received a positive response. In the current year, Sarthak has empowered 4500 Divyangjans with digital literacy. Out of this, 1150 Divyangjans have been provided with Self Employment and Entrepreneurship Assistance.

#### **Campus Connect Programme**

This is a new project by Team Sarthak. Here, we identify University Students with Disability and connect with them to understand their difficulties with respect to the job market. Following this, Sarthak helps them acquire the required skills and fills in the knowledge gaps that then helps them gain confidence in themselves and become ready for employment. Around 100 Engineering institutes were outreached, 71 were trained and 15 were provided employment support.



#### Stories of Hope - Kranti

In most cases, the environment that a PwD individual lives in disables them further. Rather than giving them the extra push and motivation that they need to succeed, what they are subject to is constant scrutiny and putting down by the people around them.

Kranti has a similar story. She was born with a locomotor disability into a low income family. Kranti's disability only furthered the issues that she already had as a result of her class and gender. Her parents got her married and suddenly she found herself in a rather unfortunate position as she felt very unwelcome in her husband's family.

When she first heard of Sarthak, she was reluctant. However, her husband motivated her. She enrolled for training which helped her develop skills and confidence. After training she got placed at Flipkart. She believes gaining appropriate skills and sustainable employment have been instrumental to her leading a life of comfort, dignity, and respect.

#### Stories of Hope - Shadab

As a visually impaired person, one of the main challenges that Shadab had to face was due to the constant social scrutiny and stigma around disability. However, Shadab tells us that he always looked at his disability as a challenge or hurdle that he needs to overcome. It is with this kind of self-determination that Shadab was able to complete his schooling and araduation level education.

While Shadab did everything we could, the world he lives in didn't cooperate. This made finding employment a herculean task. This is the point at which Sarthak stepped into Shadab's life. Shadab joined our three-month skill building course that helped him acquire the specific skills needed in the job market. Following the completion of his course, Sarthak put him in touch with Vishal Mega Mart where he has been working for the past five years as a Customer Sales Associate.



Sustainable Employment
- Supporting Financial Independence



Persons with Disability in India have a dismal rate of Labour Force Participation in India. According to Equiv.in, a recruitment platform that conducted this analysis using government data, only 34 lakhs of about 1.34 crore PwDs in the employable age bracket have jobs. Sarthak has been working on improving the figures by collaborating with hiring partners and PwD applicants.

Sarthak's sustainable employment program focuses on providing equitable inclusive employment for youth with disabilities. In doing so, we follow 8 strategies to ensure placement of a person with disability:

- Job Mapping It is the process to explore suitable job roles for persons with disability across sectors along with reasonable accommodation to effectively meet the job requirements and expected level of performance.
- Candidate Mapping It is the process of aligning the right candidate to the right profile. i.e. matching skill set as per requirement.
- 3. **Recruitment** Ensuring accessible ecosystem while conducting interviews during one-to-one placement drive

or job fairs. (Sign language interpreters, accessible technology in case of written tests etc.)

- 4. Disability Sensitisation Workshop It aims at creating awareness and a sensitized approach among different levels of workforce in an organization to work towards creating an ecosphere to have an inclusive workplace by recognizing 'ability in disability'.
- 5. **Post Placement Follow up** It is a process of hand holding the employer as well as candidates for at least 6 months.
- Campus connect Connecting with PwDs present in different institutional paradigms and extending support for getting employed.
- 7. **Job fairs** The presence of different companies on the same platform, where it provides the PwDs the opportunity to apply at different companies.
- Walk in Interviews In the endeavour to empower PwDs, Sarthak also helps non- enrolled PwDs to get in touch with the companies where they can directly appear for interviews.



#### Stories of Hope - Asif Alam

Asif's story stands testimony to the importance of normalizing disability and understanding that an individual is only as disabled as the social context renders them to be so. Asif Alam lost most of his leg functioning as a result of Polio. He's the oldest son among four children.

In spite of low financial means, his father worked day and night to make sure that Asif had access to the best possible treatment and education. It was due to his positive social environment and constant support that truly helped Asif reach great heights. Asif mentions how his friends and family were helpful at every step and truly kept him motivated. Asif has completed his BTech in Software Engineering from Jamia Millia Islamia University and currently works for Global Logic. He will soon be beginning his MBA from the same university. He appreciates the support Sarthak has provided to him as an organization.

#### Stories of Hope, Campus Connect - Abhishek Arya

The pandemic and subsequent movement of education to online mode led to a number of anxieties regarding the future in most university students. The case was even more acute in the case of students with disabilities. It was in this context that Sarthak came up with the Campus Connect Programme.

Abhishek Arya is from the first cohort of beneficiaries from Sarthak Educational Trust's Campus Connect Programme. He is a fourth year student of Dr. BR Ambedkar National Institute of Technology in Jalandhar studying Computer Science Engineering. With the onset of the pandemic and his fast approaching graduation, Abhishek had certain stresses regarding what next. Sarthak team helped him upskill and assisted in getting a job at KPMG. Reflecting on his experience with the campus connect programme, Abhishek tells us that this programme helped him learn beyond what his university course covers and obtain a good placement offer.



# Advocacy for an Inclusive Ecosystem

Sarthak's advocacy initiatives are centredaround generating awareness in order to create an inclusive world which provides persons with disabilities with a life of equality and dignity. Sarthak in its past 13 years of working has carried out a number of successful advocacy drives and connected with a variety of stakeholders. Sarthak works with a number of partners from various sectors. This includes corporate companies, NGO partners, as well as Government departments.

The advocacy highlights for the year 2021 are as follows:

#### 1. New Partnerships

In spite of restrictions from the pandemic, the advocacy team was able to form a number of new partnerships. with the UK.

The Social Media team has also been working tirelessly in creating awareness in the online space. The live sessions on Instagram have especially been engaging. Some notable live sessions have been with the Paralympians Shams Alam and Priyanka Mohanty, and another with Abilympian Sai Krishna.


#### 3. Disability Sensitization Workshops

# Indian Disability Empowerment Alliance (IDEA)



The Indian Disability Empowerment Alliance (IDEA) was launched by Sarthak in 2019 in an effort to create a common forum for cooperation among the various Non-Governmental Organizations working with Persons with Disability. The need for this kind of a forum was realized following informal consultation with a number of organizations working towards the same cause as us. So far over 250 NGOs have become a part of this alliance.

Over the past two years, IDEA by Sarthak has been able to extend support to the partner NGOs in a number of ways, as listed below-

- Have been imparting free of cost online training to PwD candidates associated with Member NGO's, across India through the pandemic.
- Conducting Capacity building sessions for partner NGOs on various topics like Financial literacy, Product marketing among others.
- Started Aap Ki Aawaz series to understand the challenges faced by NGOs in the disability sector. This platform is also used to build awareness about various Govt. schemes for financial and legal support like getting 12A, 80G, FCRA and other documents in place to apply for financial support.

- Linked partner NGOs who create products with PwDs with Government E-Marketplace (GeM) - an online platform where they can market their products.
- Helped our partners enter into MoU with Atypical Advantage to market products produced by Persons with Disability.

#### **Objectives of IDEA**

- Common Platform: To act as the common platform for the advocacy of Disability concentric issues with various stakeholders.
- 2. **Mutual Support**: To encourage mutual learning and sharing best practices between Member NGOs.
- 3. **Outreach**: To increase the total reach of the PwD community, by ensuring their empowerment and inclusion through common joint efforts.

IDEA has also been instrumental in provision of relief materials and financial support through the course of the pandemic. Continuing in its mission to empower every Divyangjan in the country, Sarthak proactively provided Covid relief measures during the second wave of the pandemic to its NGO partners through distribution of food kits to needy Divyangjan associated with them in their respective areas.

# National Abilympic Association of India - Excellence in Skills

The National Abilympic Association of India was started in2001, under the aegis of Ministries of Social Justice and Empowerment and Human Resources Development. It was formed in order to organize India's participation in the 6th International Abilympicsin New Delhi and to oversee India's participation in the subsequent years.NAAI's association with Sarthak began in December 2016 when it was handed over by Amar Jyoti Charitable Trust. Over the years, Sarthak has been able to grow NAAI's outreach given Sarthak's pan India presence and wide network of partners.

Since the past year, NAAI participants have been keenly looking forward to competing in the 2022 International Abilympics in Russia. This international event will test the participants infollowing 16 skill categories -

- 1. ICT/ Computers- Word Processing, Data Processing, Web Page Designing, Computer Programming; Character Designing; Poster Designing, Photography Studio, Photography Outdoor
- 2. Crafts- Painting, Embroidery
- 3. Services- Jewellery making, Tailoring, Dress Making
- 4. Food-Bakery, Cooking, Restaurant Service.

Over the course of 2021, NAAI has conducted an online skill assessment camp at the national level to select the best candidates for the Indian Contingent. Following this, the

candidates will now receive advanced training in order to upscale their skills for the international competition

NAAI's efforts have been further supported by our knowledge partners who help us provide quality training to our candidates to upscale their skills as per international levels. Our knowledge partners are-

- 1. Shree Guru Gobind SinghTricentenary University (SG), Budhera, Gurugram
- 2. Lady Irwin College, Delhi University
- 3. JSS College of Arts, Commerce, and Science, Mysore
- 4. Apparel Training and Design Centre, Gurugram

In the next five years, NAAI plans on further work on its mission to create public awareness and nurture the productive talent of persons with disabilities. This will be achieved by providing them opportunities to acquire and enhance their vocational skills to ensure their mainstreaming and economic independence. Other than this, NAAI will be beginning with the next cycle of selections for the 11th international competitions. This will be conducted through creation of State Nodal Agencies as well as contacting special schools and training institutes across the country. The Indian Disability Empowerment Alliance vertical will also be used here in order to cast a wider net for engaging more participants.





#### Priyanka Dabade

28-year-old Priyanka was born with a speech and hearing impairment. However, it doesn't leave her with no means to express herself as she does so beautifully through embroidery. Right from her childhood, Priyanka was interested in clothing, fashion, and styling and dreamed of becoming a fashion designer with her own line of clothing one day. On noticing her inclination and talent, her family motivated her to pursue a diploma in fashion designing in Pune after completing her schooling.

It was at this point that Priyanka came to know of NAAI and participated in regional level competitions through a nonprofit called Pune BalKalyanSanstha. She went on to participate in the West Zone Regional Abilympic competition in skill category - Embroidery, organized by National Abilympic Association of India (NAAI). She won the gold medal here and this earned her an invite to the National Level Abilympics in Delhi. She received a gold medal at the National level as well and is now preparing for the International Abilympics in Moscow, 2022.

#### **Mohith Majety**

Mohith is an engineering graduate from IIT Kharagpur with special talent and passion for photography. Admission into the university was a turning point in his life in a number of ways. He was introduced to a number of exciting new opportunities and activities. This is when he was able to develop his skills in photography.

During his engineering he got the opportunity to participate in Regional NAAl competitions in Kolkata. This began Mohith's association with NAAI. His stellar performance

gained him an invite to the national level competition in Delhi. He is one of the star performers and will be representing India at the International Abilympics tournament in Moscow in 2022.

Mohith is currently working at Genpact and talks about how he wishes well upon every divyang and hopes they keep finding new avenues in life and are able to fulfill all their goals. He is also looking forward to winning a number of laurels for the country in the upcoming international



## Digital Solutions at Sarthak

Sarthak Educational Trust has always been of the firm belief that the solutions and srvices that we provide must be in tune with the times. It is with this in mind that team Sarthak has been working on a variety of digital solutions that will help us in our cause of positively impacting each and every

Person with Disability in India. Our first ever mobile app, CapSarathi, was launched in 2020 and its success inspired the digital innovators in Team Sarthak to work on creating more digital solutions.

#### CapSarathi - Mobile App for PwDs

CapSarathi is a one stop solution for PwDs for all informational needs let it be Disability Certificate, Pension, Therapy centers for Kids, Inclusive Schools, Vocational Training Centers for PwDs, jobs for PwDs, Rehabilitation centers for PwDs and Assistive Devices. It was released by Sarthak Educational Trust in 2020 and provides relevant information at State/Districts and City levels.

#### RozgarSarathi - Job Portal for PwDs

RozgarSarathi is one of our newly launched digital solutions. This digital solution is directed towards helping persons with disability get employment at equal opportunity workplaces. It is a job portal that is accessible to persons with disability. As a digital solution, it aims to support the financial independence of PwDs by promoting available jobs and employment opportunities in Government and Corporate Organizations. RozgarSarathi also helps employers as it serves as a platform to post jobs as well as shortlist and select candidates from.

#### **Management Information System**

In order to maintain internal user records and share information with the pan India team, Sarthak makes use of a Management Information System. Doing so helps keep user records safe and assists in the analysis of programme and service outcomes through various dashboards and reports.

#### GyanSarathi - E-learning Management System for PwDs

GyanSarathi is a proposed digital learning solution that provides PwDs as well as other changemakers in the sector with learning and upskilling opportunities. This system will provide the learner with trainer led learning opportunities as well as self-learning modules. The learner will also get access to Interactive learning material in the form of documents, powerpoint slides, videos, animated content, and quizzes.

All the solutions are planned to be made Accessible for all 21 disability categories listed in RPWD Act 2016 by following WCAG 2.0 Standards. All these platforms are connected through CARS system (Central Authentication & Registration System), so the user needs to create their profile only once on any one of these portals which can then be used on any of the other portals as well.



## **Alumni Connect**

We believe that community is a very important part of successful implementation of our skilling and placement verticals. Alumni communities provide current trainees a source of inspiration and keep them motivated. It is with this in mind that we have executed the National Alumni Plan. Here, members of team Sarthak have been in touch with over 1000 Sarthak alumni from 2013 to 2021...

Sarthak ke Saarthi is the vertical feature through which we connect with alumni that have completed skill building courses with us more recently and have just begun on their path towards sustainable employment. We note that Sarthak Alumni have acted as harbingers of change in their workplaces and gone on to quash a number of stereotypes associated with the PwD workforce.

Mr. Nurain Alam is one such alumni who has made us proud. He has a locomotor disability as a result of polio. Being from a small town, he didn't have access to a lot of awareness or resources. In spite of all the odds being stacked up against him, Nurain managed to complete graduation. Following this, he was unable to find a job that matched his interests. This is the point at which he got to know of Sarthak. He enrolled himself at our skill building course and was able to find a job role that interested him. Currently, he is employed at IBM as a data analyst.

A number of alumni have also taken forward the kind of motivation and inspiration they have received from us to other fields and created a ripple movement of change. Maria Paul Williams is one such beneficiary. A visually impaired person himself, he has taken it upon himself to motivate others and currently works as a Commerce and Accountancy school teacher atDon Bosco School, Chennai. He wishes to inspire others by being a model teacher and public speaker.

I as individual feel grateful to have met Dr. Jitender and being guided in his imminent presence was a gift to my life that I will forever cherish."

His father is really thankful to NAAI for helping his son realize his true creative potential.

## **COVID** Relief and Response

The COVID 19 pandemic brought the world to a standstill in 2020 and completely changed the manner in which we as a society come together. Everyone had to radically adjust their lives to completely new modes of functioning. Even in this situation, Sarthak Educational Trust continued working towards its mission. When any kind of disaster strikes, while it affects everyone, it is the ones who are already occupying the margins of society who are most affected. Persons with Disability are one such group of people. It is with this in mind that we at Sarthak realized the need to alter our programmes and add more to our repertoire in order to cater to the needs that the pandemic has brought up.

- 3. Provided online rehabilitative therapies to 2670 Children with special needs under our Early Intervention vertical, so far
- 4. Empowered 4500 PwDs with digital literacy
- 5. Provided Support to community based NGOs in Tamil Nadu
- 6. Distributed Food Kits and COVID essential kits to PwDs across India
- Provided Capacity Building Support to over 250 NGOs working in the disability sector across India under IDEA
- 8. Distributed PPE Kits & N-95 Masks to Medical Personnel across Delhi NCR.






